



## Dear Prospective Applicant,

Welcome! Thank you for your interest in the Habitat for Humanity Home Repair Program (HHRP). Our goal is to help homeowners in Frederick County stay safe, healthy and independent in their homes. Our repair program focuses on essential repairs such as safety hazards, accessibility improvements, and critical systems such as heating, plumbing and roofing, Our program does not assist with cosmetic upgrades or routine maintenance like painting and lawn care.

## To qualify for our program, you must:

- Own and live in your home as your primary residence, in Frederick County MD
- Have repair needs that affect your safety, health, or accessibility
- Have a total household income of less than 80% of the AMI
- Be willing to provide proof of income, homeownership, and homeowners insurance

If you are interested in Habitat for Humanity of Frederick County's Home Repair Program please apply by filling out this document by hand or on our website at FrederickHabitat.Org. Once we have received your completed application, including all necessary documents, we will contact you to let you know if you qualify for our Home Repair Program. Following acceptance to the program, a home visit will be scheduled to review the requested repairs and determine the extent of which Habitat for Humanity of Frederick County is able to assist.
